

## ONLINE HEARING DATE INFORMATION

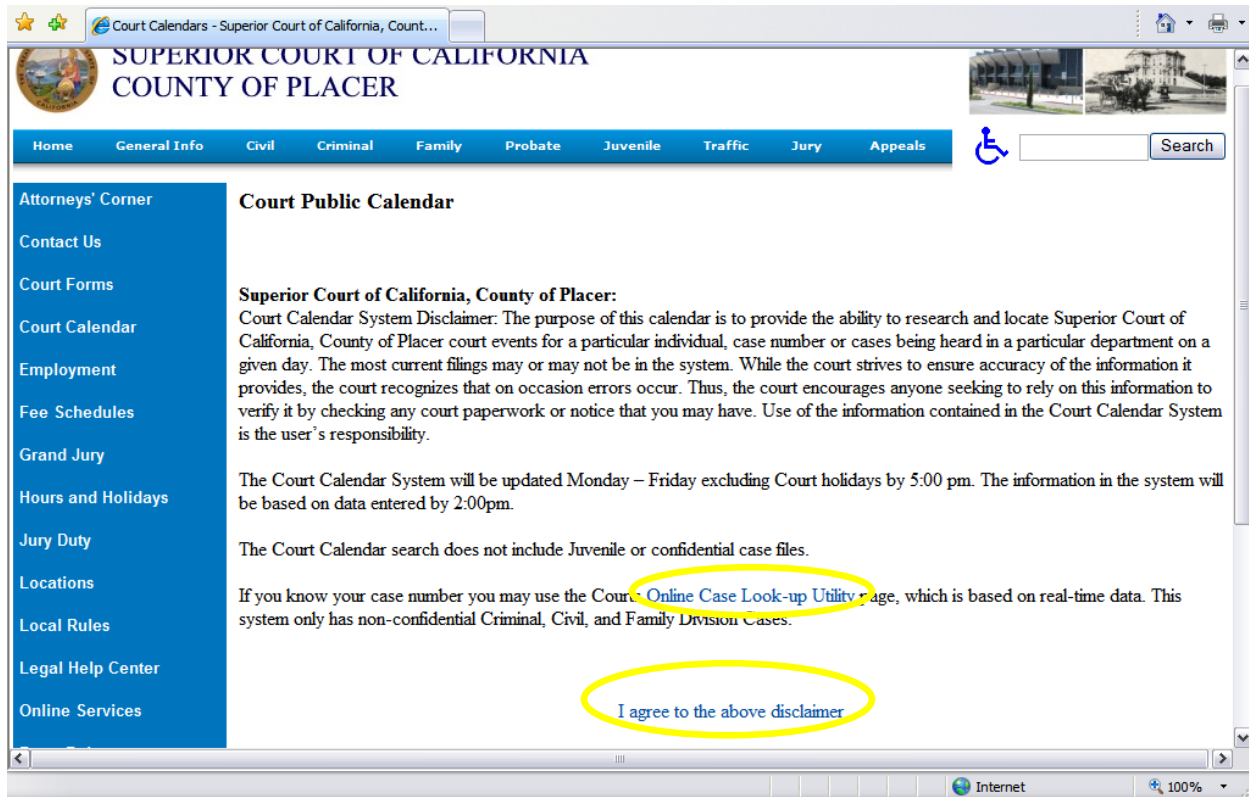
Limited information about cases is available at the court's website, [www.placer.courts.ca.gov](http://www.placer.courts.ca.gov).

This usually includes some upcoming hearing dates.

From the court's main page, select **Court Calendar** from the menu bar on the left or from the various drop-down menus.



This takes you to this page:



From here, you can look up information two ways: by clicking **I agree to the above disclaimer** (which takes you to the Public Calendar page) or by clicking **Online Case Look-up Utility** page. Let's look at both.

It may be simplest to search by Case Number, but you can search by any of the listed fields.

All civil and family (all non-criminal) case numbers are formatted as follows:

**X-XX-#####** (where X is a letter and # is a number).

There will always be three letters and 7 numbers. For example, If the case is SPR-5991, the proper format is S-PR-0005991; if the case is SDR-25874, the proper format is S-DR-0025874.

A search should show the next hearing date(s) during the next 60 days:




